- Applicable stateroom categories per class of ship are capacity controlled and subject to availability. Applicable categories and availability must be confirmed with the Royal Incentive Rewards Sales Desk at 1-888-305-4549.
- Blackout dates (Thanksgiving, Christmas and New Year's week) apply to all certificates.
- Certificates can be upgraded or applied to a different sailing at time of redemption (recipient pays difference between certificate value and lowest fare publicly available from the cruise line at the time of redemption). No money is refunded if lower cost sailing is booked.
