Booking Window: May 1 - June 30, 2024

Eligible Sailings and Products: All 2025 deployment (excluding Australia, China & Singapore)

Offer: When names & full deposit applied to group bookings at least 6+ months in advance of sailing, your clients will receive:

\$50 per stateroom Onboard Credit for sailings 4-nights or less in length
\$100 per stateroom Onboard Credit for sailings 5-nights or more in length

Eligibility: Combinable with standard group and prevailing group rates. Restricted to newly named group bookings where names and full deposit are applied during the promotional window. Individual reservations transferred into existing groups will not qualify.

FREQUENTLY ASKED QUESTIONS

1. How is the Group Rewards Program changing?

Effective May 1st, 2024, the decision has been made to discontinue the evergreen naming bonus as a component of the Group Rewards Program.

2. Are all groups impacted by this program change?

The shift in the Group Rewards Program impacts all unnamed group staterooms, regardless of when the group block was created. Group bookings named and fully deposited prior to May 1st, 2024 are unimpacted and fall under the previous program terms.

3. Will a replacement program be introduced?

Leveraged in a more tactical manner, a rendition of the group naming kicker will be periodically introduced to provide your clients with an added bonus to book early!
