

GENERAL INFORMATION

DOCUMENTATION REQUIREMENTS:

Each guest must present:

A valid Passport book or Passport card is strongly recommended to expedite the check-in process. Other government documents, such as original U.S. birth certificate (state-issued) and valid government photo ID will be accepted if valid Passport is unattainable.

ACCOMMODATIONS

- Through the invitation process, each invitee has been provided guidance on accommodation offerings, granting the opportunity to invite a traveling companion(s) of his/her choice. All ages welcome.
- One guest in each stateroom must be at least 21 years of age.
- Staterooms will be assigned at random and cannot be preselected nor changed once confirmed.
- Invitations for this event are non-transferable.

CONFIRMATION / ONLINE CHECK-IN

- All booking numbers will be shared on-or-before
 December 1, 2023. Once received, download the Royal
 Caribbean app to your mobile device and complete the
 online check-in process at least 24 hours prior to
 departure. Failure to complete online check-in may
 result in the denial of boarding.
- Royal Caribbean app check-in is available up until 8:00 a.m. on embarkation day.

CONFIRMATION / ONLINE CHECK-IN (cont'd)

- Arrival appointments are required; Be sure to select the best time for your traveling party.
- A health questionnaire must be completed via the app and will be available 24- hours prior to sailing.
- Credit cards will be required to set up your onboard account. No cash accounts permitted.

COMPLIMENTARY AIRPORT TRANSFERS

Complimentary airport transfers will be available to and from MIA and FLL airports.

Miami International Airport (MIA):

- Motor Coaches will run between 10:00 a.m. 3:30 p.m. EST approximately every 30 minutes on day of embarkation.
- The first pick up is at 10:30 a.m. and the last pick up is at 3:00 p.m.
- Flights must arrive at or before 2:00 p.m. EST
- After collecting luggage, guest should meet cruise agent at either of the following locations:
 - o Carousel #23 Concourse D
 - Carousel #6 Concourse J
- Debark Schedule:
 - o 6:30 a.m. 10:30 a.m.

Fort Lauderdale Airport (FLL):

- Motor coaches will run between 10:00 a.m. 2:30 p.m. EST approximately every 60 minutes on day of embarkation.
- The first pick up is at 10:30 a.m. and the last pick up is at 2:00 p.m.
- Flights must arrive at or before 2:00 p.m. EST
- After collecting luggage, guest should meet cruise agent at either of the following locations:
 - o Terminal 1, 2 or 3 baggage claims area
 - Terminal 4 arrivals proceed to Terminal 3 baggage claims area.
- Debark Schedule:
 - o 6:30 a.m. 10:30 a.m.

Departure: Transfers to MIA and FLL will be available on the morning of disembarkation. Earliest recommended departure flight is from MIA: 11:00 a.m.; FLL: 12:00 p.m.

TERMINAL ARRIVAL

- All guests are required to complete the Safety Briefing before the ship sails. In the terminal using the app, please launch the Safety Briefing by tapping the safety icon on the homepage. Complete the final step of the Safety Briefing upon boarding the ship at your assigned Assembly Station.
- Participants should arrive to the terminal at the selected appointment time. No exceptions will be permitted.
- Terminal parking is complimentary for this event, though space is limited due to peak season demand.
 - Should Terminal A parking reach capacity, overflow parking options will be provided once onsite. Such options include shuttle service to-and-from Terminal A.
 - Please consider leaving luggage & travel companion at entrance of Terminal A prior to advancing to overflow lot.
 - Boarding delays may occur when parking at the terminal.
- Ride sharing, such as Uber & Lyft, as well as other means of drop-off transportation, are highly encouraged.

ONBOARD

- Safety Briefing: Upon joining the ship, please ensure you check into your assigned Assembly Station.
- Cruise Compass is available via the Royal Caribbean app.
- Bar beverages will be free of charge for this event;
 Beverage packages will not be offered.
- Starbucks will be open; Complimentary drinks will be limited to size Grande only and food products will not be offered.
- Entertainment & Activity reservations can be booked online once onboard via app and box office.
- VOOM Internet will be complimentary for all guests.
- Photo purchases available at a 50% discount for Printed Photos, Digitals and Retail (electronics excluded).
- Retail shops and Spa services will be available.
- Customary Crown & Anchor Society benefits will NOT be available on this sailing (i.e. cruise points, lounge access, exclusive Pinnacle events, etc.)
