# **FREQUENTLY ASKED QUESTIONS**

# 1. Who should I contact to book the Kosher Fresh Dining Package?

The Fresh Kosher package can be reserved via the online Pre-Cruise Planner (PCP) or by calling the Pre-Cruise Planner Desk at 1-800-398-9819.

# 2. Which meals are included in the package?

Breakfast, Lunch, and Dinner will be included when the Fresh Kosher Dining package is purchased.

# 3. How are the kosher meals served?

All Fresh Kosher Dining package meals are served buffet-style in the Solarium Bistro.

# 4. Is the venue exclusively for kosher guests?

Yes, it will be exclusive for the Kosher meals served onboard.

# 5. How is the food prepared?

All kosher meals are produced under Mashgiach Temidi, all meats are Glatt Kosher, and Dairy products: some are Cholov Yisroel, some are Cholov Stam.

# 6. Do we offer kosher wine?

Yes, kosher red and white wine will be available for purchase by the bottle (limited quantities available).

#### 7. How many days before sailing can "Fresh Kosher Dining Package" be booked?

Space is limited, so we encourage you to book at least 45 days before sailing. Please note, if the program is sold out, seats will not be available for purchase onboard.

# 8. How will my clients know they are confirmed for the Fresh Kosher Dining Package?

Confirmation will be provided once the package is added through the Pre-Cruise Planner.

# 9. Is there a Rabbi onboard during this sailing?

Yes, Rabbi Dovid Weberman will be onboard or have a representing Rabbi onboard to provide Glatt Kosher Supervision. Minyanim and Torah Reading are available onboard.

# 10. Are all the meals available in all restaurants?

No, the Fresh Kosher Dining Package is only applicable to Solarium Bistro.

# 11. Are there other kosher meal options available onboard?

Other options are available outside the fresh kosher dining package; however, these need to be reserved before sailing. For these options, we require that your clients book them a minimum of 45 days before their sailing in North America. Royal Caribbean<sup>®</sup> cannot guarantee that your clients will be able to enjoy these additional kosher meals without proper notice.

# 12. How can my clients participate in the Fresh Kosher Dining Package? Be sure they book at least 45 days before the cruise date. Seating is limited and will only remain open while seats are available.

13. The program is not what my clients expected, and they want to switch to the frozen kosher program. Can this be done? Depending on how far along the cruise is, this is up to the ship's discretion. Please have your clients contact the Restaurant Operations Manager. Due to pre-registration requirements, switching to the Frozen Kosher program may not be an option.

**14.** My clients want to see the menu for the week. Please advise where this is published? Unfortunately, as the service is buffet-style, we do not have a published menu.

15. Is this program a part of the Ultimate Dining Package?

There is no opportunity to add this program to the Ultimate Dining Package.

16. Are prayer services offered this sailing?

Prayer services are a guest-led program not led by the onboard Rabbi. He may select whether to participate or lead the prayer services if time permits.

**17. Will there be a designated elevator during Shabbat?** We cannot commit to a Shabbat elevator.

**18. Which Kosher Authorization is overseeing the kosher program onboard?** Rabbi Dovid Weberman, Expert in Kosher Cruise and Kosher Culinary Cuisine since 1997.

**19.** What process does the kitchen go through to make it kosher? The Rabbi Supervises the cleaning, sanitizing, and Koshering.

**20.** What venues does Rabbi Dovid Weberman Certify? All Kosher Food Operations onboard.

**21. What onboard is not certified by Rabbi Dovid Weberman?** Casino, Swimming Pools, Entertainment, Etc.

22. Are all the Kosher Team members Orthodox?

All our Kosher Team members (Mashgiachim and Mashgichot) are Orthodox observant.

23. Will (Minyanim) prayer services be available while they are on board for all guests of the Jewish faith? The prayer service onboard is guest-led during this sailing. The Rabbi will be available for the Torah reading as needed.

#### 24. Who is preparing the food?

The Royal Caribbean culinary team onboard will have a dedicated group trained in kosher operations to prepare all Kosher food onboard for the sailing.

**25.** How does one know which dining rooms are kosher? There will be Kosher Signage at the entrances. Kosher supervisors will be present.

26. Who is supervising the food preparation and Dining Venus?

The Rabbi and his team of Masgichim and Mashgichot (Kosher Supervisors) will be supervising all food preparations and dining venues.

27. Is there always somebody around to supervise the food preparation? There will be a (Masgiach Temidi) Kosher Supervisor on duty. The kosher support team will assist in answering questions from our guests on how the food preparation is supervised.

# 28. Where are the kosher ingredients sourced from?

All food is sourced from reputable and long-term suppliers of Royal Caribbean. All meat and poultry are Glatt Kosher. Dairy products: some are Cholov Yisroel, some are Cholov Stam. Please check with the Rabbi on board.

**29.** Do you have the kosher certificates for the proteins that have been sourced? Kosher certificates have been verified by the Rabbi onboard.
